

# Activity Plan 2024

## Centre for Interdisciplinary Research on Justice (CIJ)

Porto, 14 February 2024



#### **INTRODUCTION**

The preparation of the Activity Plan for 2024 considers the Coordination Action Programme for 2022/2024 and the Activity Plan approved for 2023, the respective objectives, qualitative targets, and actions. Some of the planned objectives and actions have been completed; some have not been realised or completed and will therefore continue to be pursued in 2024. After successive postponements of the FCT evaluation process, the year 2024 was the subject of an authorisation to extend financial implementation for the period 2018-2023, with a specific budget reinforcement for this purpose.

This plan was not presented and approved in December 2023 due to the profound changes involved with the integration of the CJS into the CIJ, which would only be finalised at the end of January 2024. The first change, made in December 2023, was the renaming of the Centre for Interdisciplinary Research on Justice. The integration of CJS researchers and doctoral students in Law and Criminology into the CIJ is a task that takes up the month of January and has a very important significance for the expansion and development of the Centre's research, including as early as 2024. The same month of January saw the start of the FCT's evaluation process for the 2018-2023 period and the application for the 2025-2029 period, a process with notable changes compared to the previous one. After several changes, this process to support the hiring of career researchers by the FDUP took place in February. The FDUP Dean instructed the CIJ Board of Directors to also deal with the FCT-Tenure process. Thus, in the period between January and April 2024, the CIJ's Board of Directors is fully occupied with these processes.

In addition to the activities proposed by the Board of Directors, there are also activities indicated by the Centre's researchers. As is always the case, it is foreseeable that there will be other activities that are not included here, but that will take place. As will be seen below, 2024, when CIJ celebrates 25 years of activity, will be a year of fruitful research in pursuit of the mission and goals of the renewed Centre for Interdisciplinary Research on Justice.



## 1 - PREPARE THE EVALUATION PROCESS STARTING IN 2024 AND PREPARE THE APPLICATION FOR THE FCT CALL

**Qualitative Target**: To improve performance and achieve a "Very Good" classification. **Actions:** 

The first part of 2024 coincides with the FCT evaluation process. After the steps taken in 2023 (setting up an ad hoc committee, composed of members of the Direction and other CIJ researchers; SWOT analysis of CIJ, with the collaboration of its Members - 1st quarter 2023. Exhaustive analysis of the documents produced in the previous evaluation process, identifying the priority areas for attention - 1st quarter 2023), the CIJ Board of Directors focuses its efforts on this process, starting with the registration of the Centre (1st phase), followed by the registration and confirmation of the team (2nd phase) and the application (3rd phase). In the first phase, it should be noted that the integration of the laboratory and the other material resources previously allocated to the CJS allows the CIJ to establish itself as a medium-intensity laboratory centre. This implies a specific justification and, if accepted, will entail additional funding for the costs involved. The second phase involves the registration of 116 researchers, 46 of whom are integrated, the preparation of 10 "narrative CVs" to be presented by integrated researchers whose CV is considered core and the preparation of the collaboration agreement that will allow a retired researcher to continue as an integrated researcher. Finally, the third phase involves, in terms not yet known, the preparation of a dossier on the activities carried out between 2018 and 2023 and the research programme for the period 2025-2029. There is no denying the effort made by the members of the Board of Directors and the Science Manager in the above-mentioned set of processes.
